MINUTES OF A MEETING OF THE HICKORY BOARD OF EDUCATION

Monday, September 23, 2013

The Board of Education of the Hickory City Administrative School Unit met in regular session on Monday, September 23, 2013, beginning at 7:00 p.m., in Council Chambers at Hickory City Hall.

Members present included: Vice Chair Reginald Hamilton; Board members Charlotte Williams, Sallie Johnson, Margaret Pope, Rev. T. Anthony Spearman, and Amy Monroe; and acting Board Attorney Stephen Palmer. Absent were Board Chair Angela Beaver Simmons and Board Attorney Jeffrey T. Mackie.

Agenda Items I. and II. (Call to Order and Quorum Determination)

Vice Chair Hamilton called the meeting to order and stated that a quorum was present, noting that Board Chair Beaver Simmons was out of town.

Agenda Item III. (Pledge of Allegiance and Adoption of the Agenda)

Cadet Dalton Teague from the Hickory High JROTC lead the Board in the Pledge of Allegiance. Members of the Hickory High chorus performed the National Anthem.

Rev. Spearman made a motion that the Board adopt the agenda as presented. The motion was seconded by Ms. Pope and the Board's vote was 6-0

Agenda Item IV. (Minutes)

Ms. Williams made a motion that the Board approve minutes from the August 12 and August 26 meetings of the Board. Ms. Johnson seconded the motion and the Board's vote was 6-0.

Agenda Item V. (Public Hearing)

During the Public Hearing, Ms. Caroline Lovette, Assistant Principal at Hickory High School and Athletic Director for the Hickory Public Schools, requested permission to address the Board. Ms. Lovette announced that she had accepted a position with Asheville City Schools but wanted to publicly thank the Board for the opportunity to serve the students and staff at Hickory High School. Dr. Hart stated that Hickory High is fortunate to have had Ms. Lovette as a part of its administrative team and wished her well in her new endeavor.

Agenda Item VI. (Programs/Special Recognitions)

Dr. Hart stated that teachers from Hickory High were present at tonight's meeting to share with the Board how they are integrating technology into classroom instruction. Dr. Hart turned the program over to Ms. Terri Hall, Technology Specialist.

Ms. Hall stated that Dr. Hart has invited her to share information about the eLeaders program at Board meetings. She introduced Ms. Rachael Moyer and Mr. Chris Rice, teachers from Hickory High, who were present to share information about how they are incorporating the use of technology in the day to day instruction of students. They shared information about the use of Twitter, Cloud Technology, Google Drive and Drop Box. They talked about flipping their classrooms as well as the ability to engage their learners and create collaboratively. They thanked the Board for its support of the eLeaders program stating that it has generated excitement with teachers which trickles down to the students. As a result, they have witnessed among their students a positive reinforcement from peers, a deeper understanding of the subject, and a change in student engagement in the classroom.

Vice Chair Hamilton thanked Ms. Moyer and Mr. Rice for their presentation.
